BULK FUELS BID SPECIFICATIONS

Sealed bids will be received at the office of the Mackinac County Road Commission, 706 North State Street, St. Ignace, MI 49781 until **March 7, 2024 @ 11:00 a.m.** for providing and delivering the Road Commission's yearly bulk fuel needs.

Specification and Quantity:

Diesel Fuel: AMAOCO PREMIER OR APPROVED EQUAL, ULTRA LOW SULFUR, DYED RED. Anticipated yearly diesel usage is 90,000 gallons. The Mackinac County Road Commission has two 1000 gallon capacity diesel tanks at each garage, for a total capacity of 2000 gallons per garage.

Estimated yearly gallons are offered as a bidding guide and may vary from actual usage.

Bidder is to state current price as of noon on **March 5, 2024** rack price and the cost over rack price. Bid price must include all costs, including but not limited to: MUSTFA tax, any additives, red dye, and delivery to the Mackinac County Road Commission's garages for twelve (12) months. Bidder must provide proof of rack price, location, and date with each invoice. Bidder must state the terminal location for the rack price quoted.

Bidder must be able to deliver within 24 hours of order as well as supply and install remote monitoring system. All deliveries must be made Monday through Thursday, excluding holidays, between 6 a.m. and 2:30 p.m.

Bidders must state any other conditions that may affect their ability to meet the conditions specified.

Mutual Extension Clause:

This bid, by mutual agreement of both parties, may be extended for additional one-year periods, each year hereafter. Request for contract extensions must be in writing and received by the Road Commission no later than December 1st of each year.

The Board reserves the right to reject any or all bids, waive any defect in the bids and make awards in any manner deemed to be in the best interest of the Mackinac County Road Commission.
