### SPECIAL CONDITIONS:

1. PERMIT IS VALID ONLY WHEN THE TEMPERATURE IS 20 DEGREES FAHRENHEIT OR LOWER.
2. APPLICANT WILL BE RESPONSIBLE TO DAMAGE TO THE ROADWAY, TO PERSONS OR TO PROPERTY, CAUSED BY OR ARISING FROM THE MOVEMENT INVOLVED, AND WILL INDEMNIFY AND SAVE THE COUNTY HARMLESS FROM SUITS, CLAIMS, DAMAGES OF EVERY KIND OR NATURE ARISING FROM USE OF THE ROADWAYS INVOLVED HEREIN. APPLICANT SHALL IMMEDIATELY REPORT TO THE COUNTY ROAD OFFICE ANY DAMAGE CAUSED BY THE MOVE.
3. THE DRIVER OF THE VEHICLE SHALL CARRY THE ORIGINAL PERMIT IN THE VEHICLE TO WHICH IT APPLIES AND SHALL HAVE IT AVAILABLE FOR INSPECTION BY LAW ENFORCEMENT OFFICERS OR THE COUNTY ROAD FOREMAN.
4. IF, DURING THIS PERIOD OF SEASONAL WEIGHT RESTRICTIONS, THE MACKINAC COUNTY ROAD COMMISSION FINDS THAT A ROAD IS BEING DAMAGED, THE PERMIT MAY BE REVOKED OR ANOTHER ROUTE MAY BE DIRECTED.

1. **Specifications.** All work performed under this permit must be done in accordance with the plans, specifications, maps and statements filed with the Commission and must comply with the Commission's current requirements and specifications on file at its offices and M.D.O.T. Specifications
2. **Fees and Costs.** Permit Holder shall be responsible for all fees incurred by the Commission in connection with this permit and shall deposit estimated fees and costs as determined by the Commission, at the time the permit is issued.
3. **Bond.** Permit Holder shall provide a cash deposit, letter of credit or bond in a form and amount acceptable to the Commission at the time a permit is issued.
4. **Insurance.** Permit Holder shall furnish proof of liability and property damage insurance in the amount stated on this permit naming the Commission as an insured. Such insurance shall cover a period not less than the term of this permit and shall provide that it cannot be cancelled without ten (10) days advance written notice by certified mail with return receipt required to the Commission.
5. **Indemnification.** Permit Holder shall hold harmless and indemnify and keep indemnified the Commission, its officers and employees from all claims, suits, and judgments to which the Commission, its officers, or employees may be subject and for all costs and actual attorney fees which may be incurred on account of injury to persons or damage to property, including property of the Commission, arising out of the work under this permit, or in connection with work not authorized by this permit, or resulting from failure to comply with the terms of this permit, or arising out of the continued existence of the work product which is the subject of this permit.
6. **Miss Dig.** The Permit Holder must comply with the requirements of Public Act 53 of 1974, as amended, the contractor shall give written or telephone notice of intent to excavate, tunnel, discharge explosives, or demolish at least 3 full working days, excluding Saturdays, Sundays, and holidays, but not more than 21 calendar days, before commencing the excavating, demolishing, discharging of explosives, tunneling operations, or drilling or boring procedures. Permit Holder assumes all responsibility for damage to or interruption of underground facilities.
7. **Notification of Start and Completion of Work.** Permit Holder must notify the Commission at least 48 hours before starting work and must notify the Commission when work is completed.
8. **Time Restrictions.** All work shall be performed Mondays through Fridays between 8:00 a.m. and 5:00 p.m. unless written approval is obtained from the Commission, and work shall be performed only during the period set forth in this permit.
9. **Safety.** Permit Holder agrees to work under this permit in a safe manner and to keep the area affected by this permit in a safe condition until the work is completed. All work site conditions shall comply with the Michigan Manual of Uniform Traffic Control Devices.
10. **Restoration and Repair of Roads.** Permit Holder agrees to restore the road and right-of-way to a condition equal to or better than its condition before the work began: and to repair any damage to the road right-of-way which is the result of the facility whenever it occurs or appears.
11. **Limitation of Permit.** This permit does not relieve the Permit Holder from meeting other applicable laws and regulations of other agencies. Permit Holder is responsible for obtaining additional permits or releases which may be required in connection with this work from other governmental agencies, public utilities, corporations and individuals, including property owners. Permission may be required from adjoining property owners.
12. **Revocation of Permit.** The permit may be suspended or revoked at will, and the Permit Holder shall surrender this permit and alter, relocate, or remove its facilities at its expense at the request of the Commission.
13. **Violation of Permit.** This permit shall become immediately null and void if Permit Holder violates the terms of this permit, and the Commission may require immediate removal of Permit Holder's facilities, or the Commission may remove them without notice at Permit Holder's expense.
14. **Assignability.** This permit may not be assigned without the prior approval of the Commission. If approval is granted, the assignor shall remain liable and the assignee shall be bound by all the terms of this permit.
15. This permit is subject to supplemental specifications on file with the Road Commission and Act 200 of Public Acts of 1969.
